

Challenges – Disconnect Across the Board

Provider Data

- No central, reliable crosswalk to match provider identities
- State Medicaid rosters vary in content and fill-rates or may be unavailable

Claims

- Missing service descriptions
- Incomplete beneficiary information

MMIS Limitations


- > Lack of provider information
- Incomplete payment and billing information
- Beneficiary discrepancies
- Data latency
- False negatives and positives









- Claims Volume



Data Integration Platform

\checkmark	Extract, Transform, Load (ETL)	 Ability to interface with any system Batch, Transactional Name & address standardization (CASS certified)
\checkmark	Match	Deterministic and probabilistic matching algorithms
\checkmark	Consolidate	Flexibility to select and persist best of breed provider attributes
\checkmark	Publish	Distribute content in a consumable format

Data Governance

Key Features

- Tiered Accessibility
 - > Permissions by Role
 - > Full Access Administrator
 - > Limited Editor, Viewer
- Rich Functionality
 - User portal for data review and maintenance
 - Transactional application performs real-time record updates

Entity Maintenance

- > Merging of duplicate entities
- Split intertwined entities, e.g.,
 Father-Son scenarios
- Research and Analysis Tools
 - View raw source data contributing to the Golden Record
 - > View link movement history



Comparisons: On-premise and Hosted MDM

On-premise	Hosted
In-house resources to operate and maintain MDM solution	Reduced in-house resources need for fully- hosted customer MDM solution
Mature matching engine	Specialized matching engines
Infrastructure, software and hardware licensing are all managed internally or hosted by supplier	Infrastructure, software and hardware licensing are all managed by supplier
Deep MDM expertise required	Resources are freed to focus on other core business needs
Third party customer data source integration and ongoing quality demands managed by internal data experts	Native authoritative data source managed by Vendor
MDM business process partner needed to achieve corporate efficiency and compliance goals	Fully outsourced business processing improves corporate efficiency and supports compliance goals

Big Data Return



- High risk providers are identified and monitored for changes
- Fraud patterns and hidden partners are detected
- System capabilities streamline integration, powering analytics
- Overall costs associated with combating fraud are reduced
